 - Assistance with identifying appropriate volunteer stations and station activities

- Assist with grant requirements
 - Help identify appropriate volunteer stations and station activities
 - Assist with volunteer recruitment efforts
 - Visit stations regularly on behalf of the program to offer support to station supervisors
 - Offer assistance in collecting appropriate information from stations to fulfill grant requirements
 - Help ensure all stations understand how they fit into the big picture of national service and the impact they are having through this partnership

The Sullivan County Soil & Water Conservation District is a not-for-profit local governmental agency that is partially funded by the county and by New York State. The District's policy is the preservation of soil and water resources, and utilizing resources to enhance the quality of life, thereby helping county landowners, and municipalities with environmental issues.

The Board of Directors meeting is held every second Monday of every month and starting at 8:00 p.m. at the Cornell Cooperative Education Extension Center on Ferndale-Loomis Road in Liberty, New York. The term of the Directors is for a three-year term beginning in January.

Responsibilities of the Sullivan County Soil & Water Conservation District Board of Directors:

The OFA Council is the Advisory Council for Sullivan County **Office for the Aging: July 26, 2017.**

The Advisory Council membership should include advocates, and senior community members.

The work of the Advisory Council includes a voluntary group of citizens who provide information, guidance, advice and support to OFA as to develop, coordinate and administer services to older persons. The advisory is the key link between the community and the OFA in communicating the needs and concerns of senior residents.

Requirements of the OFA Advisory Council Members:

The Advisory Councils membership must include 50% of people who are senior citizens (60+) including minority individuals and those with greatest economic or social need as well as consumers of services funded by the Older Americans Act (OAA):

- Knowledge of human and social needs of the community;
- Representatives of older individuals in the field community service.
- Those who reflect the demographics of the service area (Seniors over (60+))
- Local elected officials.

Responsibilities of the OFA Advisory Council Members:

- Mandatory Council Role and Responsibilities:
 - Developing and administering the Area Plan
 - Conducting public hearings to promote continued and consistent messaging about the importance and value of the OFA programs.
 - The advisory council is a key link between the community and the OFA in communicating the needs and concerns of senior residents.
 - Assist with public relations and marketing of the programs to the community through presentations and community advocacy.
 - Representing the interests of older persons and helping to identify compelling community needs that can be addressed by the OFA program staff.
 - Reviewing and commenting on all community policies, programs and actions, which affect senior residents.

- Additional responsibilities:
 - Assist with performing community needs assessments;
 - Help define community needs and/or assist with annual community open forum.
 - Advising on fiscal matters and budgetary reviews
 - Reviewing and commenting on proposals submitted for funding;
 - Work with OFA staff to identify community needs, developing strategies to assist in reaching isolated older residents;

At this time there are seven open positions on the OFA Advisory Council.

The OFA Advisory Council meets on the first Monday of the months; March, May, June, August, October and December at 10:00 am in the Legislative Committee Room (2nd floor) in the Government Center.

The Sullivan County Revolving Loan Fund Advisory Board (RLFAB) is responsible for reviewing applications and business plans to determine eligible program participants for four loan programs administered by the Division of Planning & Environmental Management (DPEM) known as the Sullivan County Revolving Loan Fund (RLF).

The Sullivan County Revolving Loan Fund provides seed capital and early stage loans to eligible entrepreneurial companies who want to establish or expand businesses in various sectors in Sullivan County. Special consideration shall be given to assisting businesses owned and operated by persons of low-to moderate-income, as required by the program.

DPEM administers four different revolving loan program funds that assist various entrepreneurs looking to establish or expand businesses. The four programs are:

1. Agri-Business RLF
2. Agri-Business Micro-Enterprise RLF
3. Main Street Business RLF
4. Main Street Micro-Enterprise RLF

The RLFAB meets on an as needed basis, as applications are received on a rolling basis throughout the fiscal year. Meetings are generally held from 8AM – 9AM in the DPEM office. Meeting notice is generally two weeks prior but is dependent on Board member's availability.

At this time there is one open position on the Sullivan County Revolving Loan Fund Advisory Board. Potential board members should have familiarity with business and financial planning and be cognizant of community and economic development issues within the County. Knowledge of agricultural issues and business is also a plus.
